Ground Space Application – Terms & Conditions

Annual Show— Friday & Saturday 13th & 14th March 2026

Site Prices:

[1] Lawn Area, \$100 - \$200 dependent on site allocated. Refer to site map and spreadsheet

[2] Jack Beer Pavilion, \$70 per 3 meter frontage

[3] Agricultural / Industrial Area, 6 meter frontage, \$100

Please Note: The Ground Steward will allocate sites after considering relevant requirements and suitability. The Ground Steward and the committee reserve the right to transfer a booking from “Lawn Area” to the “Agricultural/Industrial Area” if:

- a) The goods being sold, exhibited etc. are not compatible with the surrounding stands, or
- b) The area required is not compatible with the surrounding stands,
- c) Any other reason that may occur which will render the stand not compatible with the surrounding stands.

Vehicles are not permitted to remain in lawn area after sites are set up without approval from the Ground Steward. Cars or small vans may only be left on sites: 1, 2, 4, 5, 7, 24 and 25.

Full payment is required to confirm site allocation. If payment has not been received by the Tuesday prior to the show, sites may be reallocated. On receipt of payment 2 gate tickets will be issued for entry to the ground. Payments may be forfeited for “non-attendance” at the show. If more gate passes are required these can be purchased at a reduced price of \$10.00 ea. with application up to 2 weeks before show, maximum number of extra passes is 2.

Public Liability Insurance Cover—Trade Space Holders

Please note the Department of Crown Lands, the owners of the showground, require that each trade space holder have current Public Liability Insurance cover of no less than twenty million dollars [\$20,000,000.00].

A copy of your Certificate of Currency must accompany your application for ground space. Just quoting your policy number on the application is not acceptable. No trade space holder will be permitted to operate at the Coonabarabran Show unless they have public liability insurance of no less than \$20,000,000.00

Important notice to all trade Space holders - any trade space holder intending to bring electrical equipment to the showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow trade space holders and the general public and is a requirement of the Work Health and Safety Act 2011. The act imposes very severe penalties in the event of noncompliance with provisions. Any trade Space holder who does not comply with the provisions of the act will not be permitted to exhibit at the showground.
